The district utilized a committee approach and held multiple meetings which included relevant stakeholders. These stakeholders include teachers, administration, the school nurse, school safety specialist, CSE/CPSE Chairperson, transportation supervisor, school support staff, students, and parents. Over the summer, this committee communicated through email on several occasions, then met twice in-person to review, give feedback, and develop an implementation plan. This committee remains active and works together through updates to any COVID plans as guidelines and requirements change.

Given the relatively small amount of funds received, the district will not be using this funding for COVID prevention and mitigation strategies. Instead, the funds will be used to off-set the cost of 1 Elementary Teacher Salary to service students in need of extra help or remediation due to the learning loss impact of the COVID-19 pandemic. This interventionist's main goal will be to bridge gaps in student achievement from the shutdown of schools and the continuously changing learning environment brought on by the pandemic.

4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

The district will use academic progress monitoring with fall, winter, and spring diagnostics, and monthly growth checks using I-ready for all students receiving AIS and Response to Intervention supports. The AIS/RTI teacher had a goal to bridge gaps left by remote learning and home instruction during the shutdown and continued academic deficiencies caused by the pandemic.

The funds will be used to off-set the cost of 1 Elementary Teacher Salary to service students in need of extra help or remediation due to the learning loss impact of the COVID-19 pandemic. This interventionist's main goal will be to bridge gaps in student achievement from the shutdown of schools and the continuously changing learning environment brought on by the pandemic.

We're only receiving \$67,832 and intend to use all of the funds in the 2021-2022 school year.

The AIS/RTI teacher for which these funds will be used works with students from all student subgroups. Throughout RTI process, we identify students who are in most need of academic interventions and assign them to the appropriate interventionist. Many times, students from low-income families are identified through this process. We do have one student of color who has been identified through the 504 process, and is receiving related services. All learners with disabilities are continually monitored through the CSE/CPSE process and are given ample service to meet their needs. Currently the district has a strong special education faculty to support these needs.

Currently, the district has no students experiencing homelessness, children in foster care, English Language Learners, or migratory students.
