## Budget Vote On May 16

A high school student from a rural upstate school is tapped to serve as the Youth & Government student Lieutenant New York State Governor while gaining the confidence of more than 500 Youth & Government student participants attending from throughout New York state. Kindergarteners learn about the water retention in clouds with a hands-on experiment while their peers in 5th grade work with local organizations to stock trout in our lakes and have a hand in the banding of migrating birds. The outstanding teamwork of a group of student athletes is highlighted on a local TV news program while town and school work together to host elementary team athletic opportunities yearround. High school students can take college courses for credit and get a head start on their higher

consideration a budget has been developed that is less than the state-imposed tax cap limit, with an overall increase of 2.46% from last year's budget. Mr. Timothy Daken and Mr. Jesse Foy have both filed petitions
