<sup>1</sup> The basic school tax relief (STAR) exemption is authorized by section 425 of the Real Property Tax Law. The annual budget vote for the fiscal year 2016-2017 by the qualified voters of the Bolton Central School District, Warren County, New York, will be held at Bolton Central School in said district on Tuesday, May 17, 2016, between the hours of 12:00 p.m. and 8:00 p.m., prevailing time in the Bolton Central School, at which time the polls will be opened to vote by voting ballot or machine.

### What is STAR?

۲

STAR is a partial property tax exemption and rebate program from school taxes. New York state property owners with incomes of \$500,000 or less are eligible for STAR on their primary residence regardless of income. Basic STAR works by exempting the first \$30,000 of the full value of a home from school taxes. For senior citizens with incomes of \$84,500 or less, the Enhanced STAR program works by exempting the first \$65,300 of the full value of their home from school taxes. Please note that due to the 2% limit on STAR savings increases, the savings on your individual tax bill may not reflect the entire value of the certified STAR exemption

### District Will Use New Voting System

Bolton Central School District voters will be using new optical scanning machines when they vote on the school budget and select two members for the Board of Education on Tuesday, May 17th from noon until 8 p.m. School districts are no longer allowed to use the mechanical lever machines, which are not in compliance with the 2002 Help America Vote Act.

۲

Instead of pulling levers in a traditional voting booth, residents will be given a paper ballot and a privacy folder. They will take the ballot to a privacy booth, mark the ballot with a pen, fill in the oval that reflects their choice, and then slide it into the privacy folder. Residents will then carry the folder containing the ballot to an optical scanning machine. The voter will then slide the ballot into the machine and the vote will be registered. The process is similiar to inserting a check for deposit in an automated teller machine (ATM).

Poll workers will be able to assist anyone unfamiliar with the new voting method. There is an informational video on the Warren County Board of Elections website at http:// www.warrencountyny.gov/ boe/machine.php. On behalf of the Bolton Central School District Board of Education, administration, staff and, most importantly our students, I would like to present the 2016-2017 Bolton Central School District budget for your consideration.

As President of the Board of Education, I can assure you that the budget development process is a responsibility we take as seriously as our commitment to the success of our students. Equally important is our commitment to provide a responsible fiscal plan to

you, our constituents. The upcoming budget will be less than a 1% increase over last year's budget; 0.97% to be exact. Due to some additional state funds, the tax levy will increase by 0.79%.

Voting will be held from 12 noon to 8

p.m. in the Bolton Central School gym lobby. Completed petitions have been received by Ms.

Michelle Calzada, Mr. Richard W. Huck, Jr. and Mrs. Denise Johnson. Incumbents Mrs. Debra Peterson and Mr. Carl Schoder have decided not to seek re-election. If you see them out and about in Bolton, please thank them for their years of dedicated service to the children of our community.

This school year has provided exciting opportunities for our students at every grade level to work with technologies of many kinds. Plans are well under way for a Maker Space for our elementary students with plans for similar opportunities for secondary students on the drawing board.
