- C. Mrs. VanAuken asked about tele-communications. Mr. Learning. President Gabriels commented that the benefits did not outweigh the expenses. Mrs. VanAuken commented that this should be available for both special needs students as well as advanced students.
- D. Mrs. Peggy Reilly asked about a class in self-defense. Mr. Gaddy said that was covered in the Health classes. Mr. Switzer remarked that it is sometimes part of Wellness day or covered by the Dare Officer.
- E. Mrs. Kingsley mentioned that students should know who does what on a college campus, ex. Bursar etc. Mr. Switzer said that was covered in Senior Seminar with Mr. McCarthy with our High School Guidance Counselor, Denise Clark, assisting.
- F. Ms. Bailey would like writing and math labs to be on a permanent schedule after school for the high school students. She also suggested National Honor Society students tutoring after school and receiving community service hours for their time.
- G. Mrs. Tina Mandinec mentioned she felt that more formal guidance was needed for parents of children with special needs. Steve Wilk suggested approaching the case managers first. Claire Kingsley suggested calling the Parent Advocate, Kathy Conover.
- H. Ms. Mel Quigan noted that the new board members were doing a great job.

- I. Ms. Cindy Watkins noted that she had contacted her lawyer regarding the loss of her job at Bolton Central School and does not believe the reasons they were giving for letting her go were legal.
- J. The sports issue was brought up again and discussed. There was discussion about merging and what the different consequences would be if that did happen.
